#### A.G.M. Report

Mr P. Neary of the Clean Air Society addressed the meeting. The Association supports the aims and objectives of the Clean Air Society and is a subscription member. A pleasant Wine and Cheese Evening was held after the meeting, a charge being made to cover the costs. The annual subscription was held at \$3.00 a family or \$2.00 senior membership, the subscription year being July '82 to June '83. It cost \$238.70 to run the Association and publish the Newsletter last year, so we need at least 80 families out of the 1,000 families in Beckenham to provide this positive support. Can we ask you to consider being one such supporter? We assure you that it will assist your neighbourhood.

#### Beckenham Park Play Equipment

Work commenced on 18th August but has had a set back due to delays with materials. We have urged the City Council Parks and Recreation Department to complete the project prior to the Christmas Holidays. All materials are now on site and the contractor reports there will be no further break in the work. We look forward to the completion of this exciting project.

#### Beckenham Bus Stops

We are sure that many shoppers and motorists who pass through the Beckenham Shopping Centre will join with us in congratulating the Transport Board for their thoughtful resiting of the Bus Stops on Colombo Street. Your Association had expressed concern to the Board and we are sure the new sites will not only increase safety in the Area but also improve traffic flow.

#### Local B.M.X. Track

Following an approach from the Heathcote County Council provoked by interest from local children, the Christchurch City Council sought an opinion from this association on a proposal to provide a B.M.X. track on City Council land in Hunter Terrace. We met with Mr Crosbie, the City Waterworks and Services Engineer and Coucillor Close, Chairman Works and Traffic Committee to discuss the proposal. After a full discussion of the two possible sites suggested we replied to the City Council in the following manner:

16 October 1982

Dear Mr Crosbie, Re: PROPOSED BMN TRACK ADJOINING HUNTER TERRACE

Following our Committee's meeting with Cr Close and yourself to discuss the above project, I write to convey the Association's view as summerised in the following points:-

- We note that the site which it is proposed to lease to the Heathcote County Council ( site "B", next to the indoor rifle range) has advantages over the originally proposed site "A".
- We note that the terms of the lease provide for an annual review.
- We note that the envisaged bmx track is expected and intended to operate on a fairly modest scale.
- 4. We note further that the Heathcote County Council will erect a security fence to isolate the track from the adjoining City Council land, and will install appropriate structures to control entry to and egress from the track, effectively restricting its use to pedal cycles, and that these measures will be among the conditions to be attached to the lease by the City Coucil.
- 5. We consider that the above noted features of the proposals outlined to us by Cr Close and yourself broadly overcome the objections expressed in a recent petition against the creation of a BMX track on land adjoining Hunter Terrace and that the track envisaged in the proposals outlined at our meeting constitute, on balance, an acceptable amenity.
- 6. We consider that it would be appropriate, although we do not represent Heathcote residents, for Heathcote County Council to consult with us on matters relating to the proposed BMX track.

I trust you will find the above observations of assistance.
